



9. Late/Conditional or incomplete tenders will not be accepted. Canvassing of any kind, direct or indirect, shall lead to disqualification of the tenderer.
10. Tender in any form other than the prescribed form will not be entertained and will be summarily rejected.
11. After submission of the Bid, the bids cannot be Revised / modified. In such cases the tender will be summarily rejected and the entire Earnest Money Deposit submitted with the tender will be forfeited.
12. G.M University reserves the right to have selection of item listed in the Tender Call Notice from any company / manufacturer depending upon the design, requirement of item by end user and technical specification of the item. No claim from any vendor shall be entertained by G.M University.
13. Depending upon the requirement, order will be placed by G.M University either by decreasing or increasing the quantity.
14. While quoting price, bidder should ensure one rate for one item not multiple rate of different brand for one item.
15. The bidder shall furnish photocopy of GST registration.
16. **PENALTY CLAUSE:** In case of any delay in delivery and installation of the items within the time period as agreed upon, G.M University shall have the right to charge penalty for late delivery & installation & commissioning @ 5% of the contract/Order value per week.
17. Tender shall remain valid for a period of 180 days after the last date specified in the tender.
18. The bidder shall provide one year on-site technical support for the equipment provided and response time shall be two working days.
19. The bidder shall enclose brochure with the technical bid having detailed technical specification of the equipment proposed to be supplied against the tender enquiry.
20. The bidder shall enclose brochure with the technical bid having detailed technical specification of the equipment proposed to be supplied against the Quotation call enquiry.

The software shall have superlative range of flexible functions such as, late-in Early-out policy overtime policy absentee policy, Multiple Holidays, manual entry and correction entry. Exit Events and Attendance summary as a part of Time- Attendance software. It should have provision to create multiple branches department, search designations grades and categories.
23. Supply, Installation & Commissioning should be completed within 15 days from the date of receipt of the order otherwise Liquidated damage will be charges @ Rs. 0.5% per week or part thereof subject to a maximum of 10% of order value which will be deducted from the payment due.


