In light of the Complete Lock-down announced by the Hon. PM during his address to the Nation at 08:00 p.m. on dt. 24.03.2020, the Gangadhar Meher University will observe complete closure till 14th April 2020 and until further review on 15th April, 2020.

Consequently, all examinations scheduled by the GMU are hereby postponed and the next announcement about the dates of the examinations will be made after further review on 15th April, 2020 or after the withdrawal of the lock-down notice by the central government.

All teaching and non-teaching staff members are hereby advised to remain in the headquarters and stay in touch with the university administration through digital/social media platforms till the nation-wide lock-down period gets over.

All heads of departments/schools are hereby requested to add the Deputy Registrar (+91-9437194881) to their student's WhatsApp groups for overseeing proper dissemination of information and sharing of online study materials by the HoD and teachers of the concerned departments during the period of lock-down.

All newly appointed teachers under order of joining are hereby allowed extension of their joining date till further review on 15th April 2020.

The Security Officer along with the PEOs and Student Welfare Officer are hereby directed to remain vigilant in the matters of campus safety and security. They are instructed to furnish report on the status of the campus on day-to-day basis to the administrative authorities of the University. The Head Clerk is instructed to look into the campus issues, like supply of electricity, water supply, hygiene & sanitation and watering of plants with the help of the respective categories of staff without subjecting them to the risk of violating the rules of national lock-down.

All the students and staff members are advised to maintain social distancing without fail and make as many people aware as possible to curb the menace of the COVID-19.




