2. A presentation should also be prepared by the faculty members under the guidance of the concerned HOD clearly mentioning the vision & mission, SWOC analysis, syllabus, achievements etc. (for details please refer to the supplied form).
3. The ppt mentioned in point 2 should be presented before the university academic performance audit monitoring committee on 21st March 2022.
4. The COE section is requested to furnish all information related to 1(a) of the supplied form to all the Schools for the academic year 2020-21 on or before 16th March 2022 by 12:00 PM.
5. A Google form to be circulated among the pass-outs (UG and PG) for the batch 2020 and 2021 for the information related to point 1 (d).
6. For 1(e), the data to be furnished is upon the assumption that a student, who has not taken a readmission, has discontinued his studies. Academic section is requested to furnish the information to the schools on or before 16th March, 2022 by 12 PM.
7. System manager cell is requested to furnish the departmental data regarding 4(a) on or before 16th March 2022 by 12:00 PM without fail.
8. A copy of the presentation, hardcopy and softcopy of the filled-in form etc. to be submitted to the IQAC with all supporting document in a single folder.

9. HOD's are required to assign responsibility to all the faculties and submit the responsibility chart to the committee.
10. The data to be furnished for the academic year 2020 – 21 only.
11. All document/ report related to parent-teacher meeting, mentor-mentee meeting, outreach program, webinars/ seminars/ conference/ workshop, first page of publications, project offer letter etc. should be kept in a folder both in hardcopy and softcopy form.
12. All documents mentioned in point 11 should be readily available through a hyperlink placed in the ppt for final presentation before the audit monitoring committee.
13. School-wise alumni record (even the print copy of whatsapp/ email group) etc. should be kept in readiness.
14. Each faculty should be well aware about the EBSCO (User ID: odisha_ns323168; Password: odi@ns323168#) and Scopus (Elsevier) database login details (User ID:librarygangadharuniversity@rediffmail.com; Password: Elsevier@123). The faculties are required to download at least 10 papers related to their field from the database and encourage students and research scholars to maximize their hits and download to these databases before the visit of the committee to the respective Schools. The monitoring committee may ask/ verify/ perform a mock drill related to the login during their visit.
