### Terms and Conditions

. . 1

- i. That the Gangadhar Meher University, Sambalpur, Odisha is assigned to prepare 05 no. of Peoples Biodiversity Registers (PBRs) in 05 Gram Panchayats (GPs) where Biodiversity Management Committees (BMCs) are already constituted. The list of GP level BMCs are enclosed in Annexure-I.
- ii. That the Peoples Biodiversity Register development process shall follow the latest guidelines of National Biodiversity Authority (NBA). Gangadhar Meher University, Sambalpur, Odisha shall prepare the PBRs in the recent format prescribed by NBA.
- iii. That the Gangadhar Meher University, Sambalpur, Odisha shall appraise the members of the concerned village Panchayat about the formulation of the Peoples Biodiversity Register and shall take the view and guidance of Sarpanch and other BMC members both prior to and during the Peoples Biodiversity Register development process.
- iv. That the Gangadhar Meher University, Sambalpur, Odisha will collect all relevant information relating to all types of biodiversity in the landscapes of the selected Panchayats and compile the same, validate it for its scientific names by conducting PRA with various user groups and stakeholders of biodiversity and in collaboration with technical personnel, local Vaidyas, key informants etc.
- v. That the data and information regarding biodiversity and indigenous knowledge on use of the biodiversity shall be documented in reference to various forest, agricultural and other landscape and water bodies.
- vi. That the Gangadhar Meher University, Sambalpur, Odisha will provide the soft copy of the Peoples Biodiversity Register and 3 hard copies (Odia and English) as the final output to Odisha Biodiversity Board separately for each GPs.
- vii. Along with the report, the Gangadhar Meher University, Sambalpur, Odisha shall submit photo, specimen in respect of unique data and information.
- viii. That the Gangadhar Meher University, Sambalpur, Odisha will also consult various field functionaries as and when necessary for validating information gathered from villagers.
- ix. That the Peoples Biodiversity Register in respect of 05 nos. of village Panchayats are to be formulated and submitted by Gangadhar Meher University, Sambalpur, Odisha on or before 31.07.2018. The agreement may be extended by the Authority for further specific period.
- x. That in the event the Peoples Biodiversity Register prepared by Gangadhar Meher University, Sambalpur, Odisha will be found to be deficient, inappropriate or irrelevant after the same is evaluated by an expert committee of Odisha Biodiversity Board, the same will be revised accordingly by the University as per the advice of the Odisha Biodiversity Board.
- xi. That an amount of Rs. 90,000/- (Rupees Ninety thousand only) per PBR will be paid for complete and successful formulation of Peoples Biodiversity Register. An advance of 50% for 05 PBRs will be given by the Board. Further 30% will be released after

- approval of draft PBRs. Rest 20% would be paid on final submission and approval of the PBRs.
- xii. That the Gangadhar Meher University, Sambalpur, Odisha shall not publish any Intellectual Property Rights (IPRs) material related to traditional Knowledge (TK) and patents of local knowledge holders regarding uses of bioresources without prior consent and recognition of the knowledge holders.
- xiii. Unutilized amount, if any shall be refunded to Member Secretary, Odisha Biodiversity Board.
- xiv. University may be assigned more number of PBRs depending upon successful completion of assigned work.
- xv. Any dispute regarding the assignment and execution of agreement will be arbitrated by the Chairman, Odisha Biodiversity Board which will be binding on both the parties.

As the aforesaid terms and conditions are acceptable to Odisha Biodiversity Board, Bhubaneswan and Gangadhar Meher University, Sambalpur, Odisha, the authorized representative of both the organizations hereby affirm to abide by the above and signed as under.
