Besides this institution has been notified as the Nodal Centre for doctoral and post-doctoral research in Pedagogical Sciences and Education. Dr P.M. Each individually referred to as a "Party" and together as the "Parties", both enter into a Memorandum of Understanding detailed as stated below.

OBJECTIVE:

The MoU has been drawn up and agreed upon to establish academic and allied cooperation between the School of Education, Gangadhar Meher University, Amruta Vihar, Sambalpur. 768004, Odisha, and Dr. Parshuram Mishra Institute of Advanced Study in Education (Dr.P.M. IASE.) Motijharan, Sambalpur, Odisha.

ARTICLE-1. PURPOSE

The purpose of this MoU is to enable co-operation between the School of Education, Gangadhar Meher University & Dr. P.M. IASE, Sambalpur, Odisha to strengthen relationship between the two academic institutions by developing collaboration in various academic fronts: research, innovation, development and training of faculty and students on areas of mutual interest.

ARTICLE-2. SCOPE/AREAS OF COOPERATION

2.1 OBJECTIVES

- 2.1.1 The MoU relates to proposed links between the School of Education, Gangadhar Meher University, Amruta Vihar, Sambalpur, 768004, Odisha and Dr. Parshuram Mishra Institute of Advanced Study in Education, Motijharan, Sambalpur, Odisha.
- 2.1.2 Both the parties proposed to participate and co-operate in mutual discussions and joint activities in the areas stated earlier.
- 2.1.3 Promotion of joint/collaborative Research, Innovation and Developmental programmes and activities to provide opportunities of professional development of the staff and students of both the institutions; and to publish research papers, materials and patents for mutual benefits

2.2 RESPONSIBILITIES

Both the parties do hereby agree to undertake the followings:

- 2.2.1 Identification of areas of mutual academic and research interest and modes of operation of the agreed upon programmes and activities.
- 2.2.2 Provides staff and students with library, laboratory and other academic and research infrastructure as well as facilities.

- 2.2.3 Reciprocal sharing and dissemination of information, data, experiences and competency among staff and students of both the institutions.
- 2.2.4 Conducting joint research, publication & other appropriate activities between staff and/or students from each institution.
- 2.2.5 Facilitate exchange of staff, students and researchers for the purpose of teaching, collaborative study, research and extension activities.
- 2.2.6 Provides mentoring and administrative support for academic and professional growth and provide professional expert advice and support to the other party as and when needed.
- 2.2.7 Encourage partnership in any other areas as agreed to by both the parties from time to time.

ARTICLE-3. DURATION, TERMINATION AND AMENDMENT

- 3.1 This MoU will be effective from the date of signing by both parties for a period of 3 years, and may be extended further subject to mutual consent in writing by both the parties.
- 3.2 Either party may terminate this MoU by giving a prior notice of six months in writing to the other party.
- 3.3 The provisions of this MoU may be amended at any time with the mutual consent of the parties in writing.
- 3.4 The amendment, termination and expiration of this MoU will not affect the terms of activities and programmes ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the two parties.

ARTICLE-4. INTELLECTUAL PROPERTY RIGHTS

Intellectual Property Rights (IPR) generated during the research, under this MoU shall be shared in accordance with the mutual understanding of the parties at the point of filling of the patent. General rules, however, could be the following:

- 4.1 Joint Intellectual Property ("Joint IP"): the Parties shall agree that the application for patent registration and/or any other register-able rights shall be filed in joint names.
- 4.2 The IPR generated by School of Education, Gangadhar Meher University, Amruta Vihar, Sambalpur, 768004, Odisha shall file, prosecute, maintain and extend patents or other appropriate registerable rights concerning such joint IP and shall keep
- Dr. Parshuram Mishra Institute of Advanced Study in Education, Sambalpur (Dr. PMIASE) informed about the status of all such actions. Similarly, the IPR generated by Dr. Parshuram Mishra Institute of Advanced Study in Education, Sambalpur
- (Dr. P.M. IASE), shall file, prosecute, maintain and extend patents or other appropriate register-able rights concerning such Joint IP and shall keep School of Education, Gangadhar Meher University,

Amruta Vihar. Sambalpur,768004, Odisha, informed about the status of all such action. Both the parties shall execute necessary documents and provide its assistance in order to project interest of both the Parties under this clause.

4.3 No Party shall acquire any ownership interest out of the joint research and developmental activities or programmes without the knowledge and written consent of the other Party.

ARTICLE-5. CONFIDENTIALITY

- 5.1. During the validity of the MoU and three (3) years thereafter, Gangadhar Meher University, Amruta Vihar, Sambalpur,768004, Odisha undertakes on its behalf and on behalf of its students/ employees/ associates/ representatives, and Dr. Parshuram Mishra Institute of Advanced Study in Education, Sambalpur (Dr. P.M. IASE) undertakes on behalf its students/ employee/ associates/ representatives to maintain strict confidentiality and prevent disclosure thereof, of all the Confidential Information and date exchanged/ generated pertaining to Academic and Research work under this MoU for any purpose other than in accordance with the MoU.
- 5.2. Notwithstanding anything stated in this MoU, Gangadhar Meher University, Amruta Vihar, Sambalpur, 768004, Odisha faculty members/associates involved and
- Dr. Parshuram Mishra Institute of Advanced Study in Education, Sambalpur
- (Dr. P.M. IASE), Bhubaneswar, Faculty/ associates/ representatives shall not in any event disclose confidential information related to Intellectual Property to any third party.
- 5.3. The obligations set forth in this clause shall survive any termination or expiration of this MoU for a period of three years.

ARTICLE-6. SPECIAL PROVISIONS

- 6.1 Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-by-case basis in separate Memorandum of Agreements (MoA).
- 6.2 Each party will take approval from the other party in writing to use the latter's name and logo for the activities here under on a case-by-case basis.
- Both parties here shall do their utmost to ensure the smooth and efficient implementation of the mentioned programs.
- 6.4 The two parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.

ARTICLE-7 FINANCIAL IMPLICATIONS
