A meeting of the Sub-Steering Committee of NAAC was held in the Deputy Registrar's Office on 30th May 2023 at 9:00 am relating to finalization of various proposed projects and allotment of Nodal officers, Associate Nodal officers and responsible persons for various projects and activities under Criteria VII. The following members were present:

The following resolutions were taken in the meeting:

- 1. The proposal for developing an Ornamental Fish Farm in GMU campus submitted by Dr. Pradosh Ku. Acharya was discussed and will be recommended for approval with a budget of Rs.1,50,000/- for the same project including the maintenance charges.
- 2. The proposal for developing a medicinal plant conservation garden in the 2nd campus of GMU at Badsinghari was discussed and will be recommended for approval. It was further decided to identify the existing medicinal species in the 2nd campus and develop strategies for their in-situ conservation. Rs. 3,30,000/- will be recommended for sanction for the execution of the project including the maintenance charges.
