## **NOTIFICATION for CAS-2024**

In pursuance of resolution of the Department of Higher Education, Govt. of Odisha notified vide No. HE-FEIR-MISC-43/2016-7883/HE Date: 04/04/2016 and Syndicate resolution No. 31.24.2 of the 31<sup>st</sup> Syndicate dtd.21.11.2022, Career Advancement Scheme (CAS) is implemented in Gangadhar Meher University with the following guidelines and instructions:

- 1) Those teachers who become eligible for CAS promotion after 18.07.2018, their promotion will be governed by UGC Regulation, 2018 as per DHE Letter No. 32861/HE dt. 13.08.2021.
- All CAS promotion shall be governed by the instructions received from the Hon'ble Chancellor's office vide order No. 10844/SG(HE) dtd. 05.11.2021.

Eligible Teachers of the University may apply in the prescribed format for the promotion by filling the form (Part-A, Part-B and Part-C) with all annexures numbered serially, available in the University website www.gmuniversity.ac.in

Last Date: 22.10.2024 General Instructions:

- 1. The filled-in application form signed by the candidates must be submitted along with a Non-Refundable Bank Challan of Rs. 2000/- drawn in favour of the 'Comptroller of Finance, Gangadhar Meher University', payable at UCO Bank, Budharaja, Campus Branch A/C No.21010110045411. Applications without the Bank Challan shall not be considered. The 'University Copy' of the Challan should be attached with the application.
- 2. The application form duly filled in by the candidate must be supported by self-attested copies of all evidence of teaching, research experience and production of Ph.D. scholar, copies of relevant pages (1-2 pages) of the published articles, etc. as detailed in the form.
- 3. The application, through proper channel must reach the Registrar's office on or before 22.10.2024.
- 4. For detail of the Research Score please visit the UGC website/Gangadhar Meher University website.
- 5. Certificate for Refresher Course/Orientation Program /RM/FDP must be substantiated by enclosing copy of office order/permission letter/NOC issued for attending the same by the competent authority.
- **6.** Candidates are required to produce their original Certificates and Mark sheets/testimonials for verification at the time of document verification.
- 7. The candidate needs to authenticate each page of the application form and enclosures by his/her full signature on each page and should be submitted through proper channel.
- 8. Applications received in incomplete form or not in prescribed format shall be rejected.
