#### The Research score for research papers would be augmented as follows:

Peer-Reviewed or UGC-listed Journals (Impact factor to be determined as per Thomson Reuters list):

i) Paper in refereed journals without impact - 5 Points
 ii) Paper with impact factor less than 1 - 10
 iii) Paper with impact factor between 1 and 2 - 15
 iv) Paper with impact factor between 2 and 5 - 20
 v) Paper with impact factor between 5 and - 25
 vi) Paper with impact factor >10 - 30

- (a) Two authors: 70% of total value of publication for each author.
- (b) More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.

Joint Projects: Principal Investigator and Co-investigator would get 50% each.

#### Note:

- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- \*For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
- As per clarification received from UGC vide: F.9-1/2020 (PS/Misc) dated 23.12.2022 regarding the eligibility criteria for CAS promotions of University teachers:
  - i. from Academic level 12 to Academic level 13A- The Assistant Professor should produce documentary evidence that he/she is guiding doctoral candidates.
  - ii. from Academic level 13A to Academic level 14 The Associate Professor should produce documentary evidence that the doctoral candidates registered under him/her have been awarded Ph. D degree.
