2. Fees to be paid in Online mode only from Dt. 20-12-22 to 22-12-22.
3. Pay the hostel admission fees amount Rs. 8100 /- to be paid Through the link (<https://tinyurl.com/admissiongmU>)
4. Selected candidates are required to remain present personally on a day either in Dt. 20-12-22 to 22-12-22 for Hostel admission with their parents & local guardians. Students selected for hostel seat are required to provide an undertaking that their place of nativity is more than **30 km** distance from G.M.U, Sambalpur. Parents and local guardians must come to the hostel with proper identity proof & candidates having their nativity within **30 km** are not eligible to get admission into hostels even if their names are found in selection list.
5. Admission into hostel will be held from Dt. 20-12-22 to 22-12-22 between 6.00 P.M to 8.30 P.M positively.
6. Candidates will have to submit an undertaking at the time of hostel admission that she will go by hostel Rules & Regulation.
