#### Eligibility for Tender Participation

- The bidder should be a Company registered in India under the Companies Act 1956
- No Consortium will be allowed. The bidder must meet all the eligibility criteria by itself.
- The bidder must have service tax registration, income tax assesses and GST registration.
- The bidder should have a minimum ten years of experience in Web application and maintenance services as on 1st January 2024.
- The bidder must have executed or continuing similar online projects more than a year of minimum five central Govt. /State Govt. Educational Universities.
- The bidder should have experience on examination management system.
- The bidder must not have been black listed by any State/Central Govt. organizations.
- The bidder should have a full-fledged development center in Odisha

2. Time of completion of Project, the work shall be completed in all respects within 15 days from the date of issue of work order with all relevant data as required.
3. Documents to accompany the tender the bidder must submit one self-attested copy of the documents along with the tender document, failing which the tender will be treated as non-responsive and will not be accepted.
4. Pricing should be quoted in INR and quoted pricing must be valid for 180 days from the date of closing of tender.
5. The bidder has to produce updated GST certificate along with tender papers.
6. The bidder has to submit all supporting documents, credential for necessary verifications.
7. Responsibility of successful bidder would be to develop a web based application for Examination Management System. The bidder should impart training and orientation session and to maintain, update and provide security to the application developed against cyber-attacks. The Responsibility of the University is to co-operate Service Provider's work force with proper and timely inputs. Also the successful bidder has to sign an SLA (Service level Agreement) with the University.

#### Scope of the Application

- This online application will meant for all **UG, PG, Self Financing courses, M.Phil and Ph.D** courses, the application process will start with the student examination form fill up to answer sheet mark evaluation entry through the answer sheet evaluators from different locations. The admin will create evaluators and they will be logged in through the OTP as credential.
- All students will have a separate dashboard where all examination-related notices and information will be easily displayed. The students will have their exam account credentials and can manage their own profile, the student dashboard will facilitated with the academic history and can coordinate with the examination section if seeking any information or lodging a query. Students can check their course details, academic year, online form fill up schedule, semester-wise result, final result, and manage back papers form filled up if any. Online payment for the form filled up may be integrated and the dashboard will be valid for the student's academic tenure, all examination and related activities will be facilitated here.
- Apart from student examination-related activities, there will be separate section for answer sheet evaluators to put numeric values after evaluating the answer sheet of a particular student. As usual, this online application will be a multiuser-based online application, the admin will create users using their mobile no and email ID. This will be a very highly secured online application and to update the record it will ask for the SMS as
