Terms & Conditions

1. The engagement is purely contractual and temporary for a period of one (01) year from the date of joining or until completion of the project, whichever is earlier.
2. The engagement shall be governed by the terms and conditions of the OCGG project and the guidelines issued by the funding agency/University from time to time.

The appointees shall report for duty before the Coordinator, Odisha Centre for Geriatrics and Gerontology (OCGG), Gangadhar Meher University within 07 (seven) days from the date of issue of this order, failing which the offer may be treated as cancelled unless the Competent Authority condones the delay.
4. The engagement does not confer any right for regular appointment, absorption, or continuation in the University after expiry of the contractual period.
5. The services may be terminated at any time by either side by giving one month's notice or salary in lieu thereof, subject to the terms of the project.
6. During the period of engagement, the appointees shall abide by the rules, regulations, and disciplinary provisions of Gangadhar Meher University.
7. In case any selected candidate declines the offer or resigns during the tenure, the vacancy may be filled from the waiting list approved by the Selection Committee in the order of merit.
