N.B.: (1) Ragging means the following:

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing or handling with rudeness any other students indulging in rowdy or indiscipline activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has to effect of causing or generating a sense of shame embarrassment so as to adversely affect the physique of psyche of a fresher or a junior student.

(2) Punishable ingredients of ragging:

* Abetment to ragging * Criminal conspiracy to rag * Unlawful assembly or rioting while ragging * Public nuisance created during ragging * Violation of decency and morals through ragging * Injury to body, hurt or grievous hurt * Wrongful restraint * Wrongful confinement * Use of criminal force * Assault as well as sexual offences or even unnatural offences * Extortion * Criminal trespass * Offences against property * Criminal intimidation * Attempts to commit any or all of the above mentioned offences against the victim(s) * All other offences following from the definition of "Ragging".
