Regulation and Information Bulletin for admission into Certificate of Proficiency (CoP) in French Language and Diploma in French Language – 2019

- I. Gangadhar Meher University after being established in the year 2015 is looking for the academic growth of this institution as its primary objective. In congruence with this objective, the University has introduced the M. Phil Program in 15 Departments and PhD Program in 10 Departments. Now, G.M. University, Sambalpur is offering a Certificate of Proficiency (CoP) course in French language from the session 2017-18. Two batches have already been completed. This time we are offering one year diploma course in French Language.
- II. Total seats 50 per batch (No. of batches as per demand)
- III. Course fee Rs.6000.00, for COP in French Language
  Diploma in French Language -Rs. 12,000.00 for Two semesters
- IV. Program duration:- October, 2019 to March, 2020, for Cop in French Language Program duration:- -October 2019 to September 2020, for Diploma in French language
- V. Commencement of classes:- 18.10.2019.
- VI. Eligibility: Any candidate who has passed the +2 examinations or equivalent examination is eligible to apply.
- VII. Admission to CoP in French language and Diploma in French Language shall be based on merit. The merit of the candidate shall be determined on the basis of marks secured in +2 / equivalent examinations.
- VIII. Candidates can download the Admission form from the University website <a href="https://www.gmuniversity.ac.in">www.gmuniversity.ac.in</a> and submit the same with a Bank Draft of Rs.100.00 drawn in favour of "The Comptroller of Finance, G.M. University, Sambalpur and payable at Sambalpur.
- IX. The application form duly filled in along with the required documents shall reach the undersigned on or before 15.10.2019 up to 05.00 P.M. either by registered / speed post or by hand. The University will not be responsible for any postal delay in the receipt of application form after the last date.
- X. The reservation of seats will be as follows:-

a. Scheduled Caste

- 16.25%

b. Scheduled Tribe

- 22.5%

applicants selected for admission on general merit shall not be counted against reserve seats. In case of non availability of SC/ST/PH candidates, the seats will be filled up by general candidates.

- The self certified copies of the following documents are to be submitted along XI. with the application form.
  - Mark sheet and certificates of HSC / equivalent examination. (a)
  - (b) Mark sheet and certificates of +2 / equivalent examinations.
  - (c) Caste certificate from the competent authority (Revenue Officer not below the rank of a Tahasildar).
  - Physically handicapped certificate from the competent authority. (d)
  - (e) Three passport sized photographs.
- XII. The originals of all the certificates and mark sheets of HSC and +2 Examinations are required to be produced at the time of admission for verification.
- XIII. The list of selected candidates will be notified in the University notice board and will also be available on the University website. No intimations will be issued to any candidate.
- XIV. Important Notes
  - A candidate cannot claim the refund of fees, if his/her application is rejected for any reason.
  - Any misinformation found on verification of the original documents shall (b) lead to cancellation of admission & will be treated as a cognizable
  - (c) In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he/she is indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution.
  - (d) The university reserves the right to suspend the starting of the program, if circumstances so warrant.
  - (e) Submission of incomplete application / information will be rejected.
  - The decision of the Vice Chancellor relating to admission is final and (f) binding.
