Irregular Purchase of Sports Items:-

As per Procedure 54(2) of Orissa Universities Accounts Manual, 1987 any purchase of stores and materials exceeding Rs 5,000.00 but within Rs.25000.00 needs to be processed through appropriate. Purchase Committee as given below, who shall be competent to order purchases up to Rs 25,000.00 Purchases above that limit shall require approval of the Syndicate. The approval of Syndicate of the above materials from Rusa Fund was not done before the purchase.

Also it was noticed that the placement of orders has been made to the firms in a single date bifurcating to smaller units below Rs 25000.00 for avoiding sanction & approval of higher officials and tender violating the OGFR Rules & FD M.No. 4939/F Dt 13.02.2012.

The reason of such irregular expd.was asked through issue of POM.In response to the POM,the local authority replied that Noted for future guidance.

As such Rs 1836.00 needs recovery from the erring officials and Rs 91790.00 is held under objection due to irreular expd.


